#### Production process:

Scraped peel of the inner bark of mature cinnamon plants are joined together by overlaps, the hollow of which has been filled with small pieces of the same peel followed by air curing and sun drying. The product comes as sticks, known as cinnamon quills.

#### 4. FIRST AID MEASURES

- Ingestion:** No immediate danger. Do not induce vomiting, give a glass of water. If unwell seek medical attention and show this information.
- Inhalation:** Remove casualty to fresh air, keep respiratory passages clear and seek medical attention.
- Eye contact:** Irrigate with sterile water or saline for at least 15 minutes. Seek medical attention if irritation persists or tissue damage is apparent.
- Skin contact:** Remove contaminated clothing wash thoroughly with soap and water and rinse. May causes irritation after prolonged contact, if so seek medical advice.

Store in tightly sealed containers, in a cool dry place away from direct sunlight.
