The fragrance oil of Pineapple on its own, is not impacted by the IFRA code for its use in perfuming compositions, however, the components listed above are impacted.

According to the IFRA Specification Standard of Allyl esters, Allyl esters should only be used when the level of free Allylalcohol in the ester is less than 0.1%. This recommendation is based on the delayed irritant potential of Allylalcohol.

The IFRA Standards regarding use restrictions are based on safety assessments by the Panel of Experts of the RESEARCH INSTITUTE FOR FRAGRANCE MATERIALS (RIFM) and are enforced by the IFRA Scientific Committee. Evaluation of individual Fragrance ingredients is made according to the safety standards contained in the relevant section of the IFRA Code of Practice.

This certificate is based on statistical analytical data (detection limit ≥ 0.001%) and is not carried out on each batch. The stated use levels relate to this specific material alone and may not be valid when used in combination with other restricted materials.
