The essential oil of Lime Distilled on its own, is not impacted by the IFRA code for its use in perfuming compositions, however, the components listed above are impacted.

*Where the Bergapten (5-Methoxypsoralen, (5-MOP)) content of all relevant oils present in a compound has been determined, it is recommended that for applications on areas of skin exposed to UV-light, the total level of Bergapten in the consumer products should not exceed 0.0015% (15 ppm).

Essential Oils containing substantial amounts of Limonene^{**} and Linalool^{**} should only be used when the level of peroxide is kept to the lowest practical level by the addition on antioxidants in production.
